# ~ ACT OF THE TEPOELAN BILL ON THE IMPLEMENTATION OF A PRIME MINISTER'S QUESTIONS AND PROPOSAL SYSTEM IN THE KINGDOM OF SALANDA ~

Upon the passing of this bill, there shall be a Prime Minister's Question time and proposal system in the Kingdom of Salanda, in this system Citizens and Members of the Tepoelan (known as MTs) shall be able to write and ask questions to the Prime Minister in these questions to enhance the democracy of the nation, Citizens and Members of the Tepoelan can also scrutinise the actions of the Executive/Government who will have to issue a response to the questions asked of which the Prime Minister shall be required to respond as such also questions directed at Governmental Ministers shall also be required to respond to the questions asked. While also facing direct questions the Prime Minister and other Governmental Ministers can expect someone to present the questions of which can be the Speaker or the Monarch that remain explicitly neutral and only are there to present the questions and nothing else. The Government can be expected to answer all questions though they must be with in the intellectual parameters of being reasonable that shall be determined by the Speaker who shall be neutral any appeals can be taken to Salandarian courts who shall issue a ruling if needed on the parameters of being reasonable based on the law and the Salandarian Constitution but as stated the questions can also be of scrutiny at the actions of the incumbent Government's doing. The questions shall be brought every Thursday and around a 30-minute time shall be allocated to the questions as well as any proposals and they shall be answered.

The Government/Executive shall answer questions as well as any proposals more if they have any

extra time any questions that are left over shall be set for the next Thursday and so on. If Thursday is unable to be done the Speaker or Monarch who remain explicitly neutral shall announce another day to be selected that week or weeks however it shall revert back to Thursday for the weeks that follow. A record shall be set of the questions and responses of each week.

Citizens and Members of the Tepoelan can also present and state proposals to the Government/Executive within the intellectual reason as determined by the Speaker who shall be neutral but any appeals on the proposals can be taken to the Salandarian courts who shall issue a ruling if needed on the parameters of being reasonable based on the law and the Salandarian Constitution and the Government/Executive shall follow back with a response. However, the Government does not need to implement these proposals if it does not wish to unless the majority of people demand a referendum on the proposal which must be granted by the Government unlike the Question Time however proposals can be presented and stated at any time of the week of which the Government shall issue a response which shall be given 9 days for a response. For those that may not be able to present and state in person the Kingdom of Salanda shall set up channels for Questions and Proposals on its virtual institutions of which the questions and proposals shall be collected by the Speaker or Monarch who as stated shall remain explicitly neutral and shall do their job of presenting and stating questions and proposals to the Executive/Government neutrally. A record shall be set out of all the proposals each week.
