# ~ PER 2, CR6 Ministry of the Interior Framework Act of 2023 ~

~ Definition ~

This Act by resolution of the Chamber of Provincial Emissary, is to be defined as setting up a framework for the now Ministry of the Interior of Salanda and setting up its new roles and responsibilities.

~ Section One ~

The Home Office of Salanda, shall be officially renamed to the Ministry of the Interior of Salanda or just the Ministry of the Interior for short. The Minister of the Ministry of the Interior of Salanda is the Home Secretary who shall report their duties that shall have been done to the Prime Minister of Salanda. They shall also take directives that are given to them by the Prime Minister of Salanda.

~ Section Two ~

The Ministry of the Interior of Salanda headed by the Home Secretary of Salanda, shall be responsible for the NIA, standing for the National Intelligence Agency which shall be responsible for investigating crimes committed internally with a focus branch on a newer set of activities focused on combating cyber-crime, it shall also investigate corruption and fraud and be responsible for an undisclosed police service.

~ Section Three~

The Ministry of the Interior of Salanda headed by the Home Secretary of Salanda shall also be responsible for a newly Salanda Internal Police, who themselves shall be responsible for the agencies that shall be under them that shall consist of the; Office for the Protection of the Prime Minister, which shall ensure that the Prime Minister of Salanda can carry out their duties to the nation securely as well as the ministers such as the Chancellor of the Exchequer of Salanda that serve under the Prime Minister of Salanda, the Salandarian Royal Guard which shall only be used

when the National Intelligence Agency feels a citizen or citizens are in danger and protect citizens for which ever situation they are in and the Salandarian Emergency Police who shall be convened in situations of dire need, but when there is no dire need they shall be dormant. The Prime Minister shall be the only one who can call on the Salandarian Emergency Police and a directive must be given from the National Intelligence Agency.

~ Section Four ~

This shall create a leveled organizational structure with all agencies under the Salanda Internal Police reporting to the Salanda Internal Police and all departments of the National Intelligence Agency reporting to the head part of the National Intelligence Agency, with both the Salanda Internal Police and the National Intelligence Agency reporting to the Home Secretary of Salanda as the head of the Ministry of the Interior of Salanda who shall in turn report to the Prime Minister of Salanda on behalf of the Ministry of the Interior of Salanda based on the reports of the Salanda Internal Police and the National Intelligence Agency.

~ Section Five ~

As an Act of Tepoelan, this Act of Tepoelan cannot be repealed or amended by any Executive Order of Salanda. It can only be repealed or amended by another Act of Tepoelan pertaining to this subject.
