~ Preamble/Definition and Long Title & Short Title and both of the use of these titles of the Salanda Diplomatic Relations Treaties Act of 2023 (SDRTA) ~

By resolution of the People’s Channel of the Tepoelan this Act of Tepoelan, the Salanda Diplomatic Relations Treaties Act of 2023 (SDRTA), shall have its Preamble/Definition and Long Title be: An Act of Tepoelan to make provision for the establishing of an official diplomatic relations treaty template for the Foreign Ministry of Salanda and Crown of Salanda to use when establishing diplomatic relations with other sovereign states and/or nations.

This Act of Tepoelan’s short title as stated above shall be the: Salanda Diplomatic Relations Treaties Act of 2023 and shall be abbreviated as the SDRTA, of which this Act of Tepoelan and future Acts of Tepoelan and other governmental and Tepoelan documents only have to use the short title of this Act of Tepoelan not including the abbreviation of this Act of Tepoelan.

~ Section One - Who the template can be used by to officially start diplomatic relations with other sovereign states and nations and penalties for not abiding by this section of this Act of Tepoelan ~

The template of the Salanda official diplomatic relations treaty can be used by the Foreign Ministry of Salanda and the Crown of Salanda only in the means of officially starting and making diplomatic relations with other sovereign states and nations, anyone else who tries to use it to officially establish diplomatic relations on behalf of Salanda shall be penalised under this Act of Tepoelan under the offence of perjury which shall carry a penalty to be determined under what the Salandarian Justice System [i.e, the Courts of Salanda] think is reasonable in a justified response to that offence/offences.

The template of the Salanda official diplomatic relations treaty is also in the copyright holder's possession of the Government of Salanda and the Crown of Salanda and no part of the template may be used for other purposes (and the purpose of diplomatic relations and diplomacy as stated above with its offence of perjury also stated above) without permission from the official Government of Salanda and Crown of Salanda sources, any other attempt to use the template of the Salanda official diplomatic relations treaty for any other purposes shall fall under the offence of a breach of the copyright holder's i.e, the Government of Salanda and the Crown of Salanda and shall carry a penalty to be determined under what the Salandarian Justice System [i.e, the Courts of Salanda] think is reasonable in a justified response to that offence/offences.

~ Section Two - Text of the Salanda official diplomatic relations treaty template ~

The following beyond the colon in this paragraph until the next section shall be the official text of the Salanda official diplomatic relations treaty template except for the [insert nation] with their squared brackets which shall be replaced when in use with the sovereign state's official name and/or nation's official name that Salanda is entering into official diplomatic relations, also as well under the signed with its colon at the very bottom of the Salanda official diplomatic relations treaty template shall be where Salanda and the other sovereign state and/or nation shall put their official signatures:

~ Treaty of Diplomatic Relations between the Kingdom of Salanda and the [insert nation] ~

~ Preamble ~

This treaty establishes official diplomatic relations between the Kingdom of Salanda and the [insert nation] on the day of [insert date], with the mutual recognition, between both of the nations as

sovereign, free and independent nations with the mutual recognition between both nation's pertaining as well to each nation that as a sovereign independent state both nations are capable of establishing foreign relations, declaring war, concluding peace, establish commerce, contract alliances, and do any other acts that are widely recognized by sovereign states and/or nations as necessary for a government to be recognized as the government of an independent and sovereign state.

#### Article I

It is mandated that the Kingdom of Salanda and the [insert nation] mutually respect the institutions, laws, claimed territories and the citizenship of both the signatory states and their citizens (As part of the establishment of official diplomatic relations between the two nations).

#### Article II

Both the Kingdom of Salanda and the [insert nation] shall be able to work and will be able as a consequence of this treaty to enter a special partnership on projects with the other. Both shall be able as well as bound by this treaty to work on collaborating with one another on minor projects (with minor projects being defined as projects not lasting more than a week) and shall have an exclusive relationship should both nations collaborate on major projects which are defined as an outcome with both nations working together to try and produce that outcome (for example: economic development programs and climate change prevention programs) that are proposed by one another with the projects falling in the boundaries as defined by this treaty. All projects proposed by both nations are non-mandatory, but by working together on these types of projects, this treaty stipulates that it hopes that the mutual benefit which will contribute to the further strengthening of ties between both nations. (These projects shall be stipulated in future documents that come about as a result of this treaty).

#### Article III

The Kingdom of Salanda and the [insert nation] shall undertake the extension of their corporate and cultural relations by promoting cultural collaborations (For example: Sister City Agreements between the Cities of both nations) between one another, supporting each other in foreign policy, unless there is a state of conflict based on each nation's own fundamental principles.

## Article IV

It is with positive intentions that both nations align in mutual recognition, alliance, friendship and collaboration and that the treaty may be modified as well as extended with the consensus of both parties.

~ Section Three - Additional things to put in the Salanda Official Diplomatic Relations Treaty and the documentation of it ~

Other additional things to put in the Salanda Official Diplomatic Relations Treaty are the Coat of Arms of Salanda and the other sovereign state/nation , the Seal of Salanda and the other sovereign state/nation and the flag of Salanda and the other sovereign state/nation which shall be placed at the top only before the treaty text itself, however the use of these additional things are optional and are not mandated by this Act of Tepoelan.

The Salanda Official Diplomatic Relations Treaty Template when in use for making treaties are exempted by this Act of Tepoelan and it shall not be mandated by this Act of Tepoelan to print it off for official documentation however they can if they want to, any official diplomatic relation treaty that Salanda enters into that is printed off however, (this applies to when the Salanda Official Diplomatic Relations Treaty is in use and when it isn't in use) shall be transferred to the Archival Commission of Salanda where after three days it shall thereafter be in the property of the Salanda National Archives.

~ Section Four - The Salanda Official Diplomatic Relations Treaty mandating ~

While the Foreign Ministry of Salanda and the Crown of Salanda are mandated to use this treaty template when they are the ones taking helm of the treaty, they can only make use of this official template in this Act of Tepoelan and cannot make any edits to it on their own behalf, the other sovereign state/nation can make treaty instead for the Foreign Ministry of Salanda and the Crown of Salanda if it is a foreign nation making the treaty, however all of these sections only apply to diplomatic relations treaties, but not other agreements and treaties and documents and pacts

between Salanda and over sovereign states and/or nations that can be specified differently.

~ Section Five - Enforcement of this Act of Tepoelan ~

Whereby it is declared that upon this Act of Tepoelan becoming Law of Salanda that the Government of Salanda shall be held solely responsible and accountable for the enforcement of this Act of Tepoelan in how it is enforced according to this Act of Tepoelan's sections.

~ Section Six - Entry of this Act of Tepoelan into Law of Salanda ~

This Act of Tepoelan shall become effective as a law of Salanda upon the signing of this Act of Tepoelan after being passed by the Chamber of Provincial Emissary of the Tepoelan and as such this Act of Tepoelan shall become enforceable as a law of Salanda upon the Royal Seal of Salanda being placed upon this Act of Tepoelan.

~ Section Seven - Status of this Act of Tepoelan as part of the Law of Salanda ~

This Act of Tepoelan cannot be repealed or amended by an Executive Order of Salanda and as such can only be repealed or amended by another Act of Tepoelan or by an Amendment to the Constitution of Salanda also known as the Basic Foundation Laws (of Salanda).
