~ Salanda Online Privacy Protection Act of 2022 Amendment Act of 2025 (SOPPA) ~

The preamble and definition of this Act, the Salanda Online Privacy Protection Act of 2022 shall be as follows: An Act of Tepoelan to provide for the privacy and protection of everyone in Salanda from harmful and offensive content.

Note that this preamble/definition are legally not part of the Act of Tepoelan itself (except the title of this Act of Tepoelan the Salanda Online Privacy Protection Act of 2022 is the legal name of this Act of Tepoelan under the law of Salanda) but are there to explain and summarize it, the sections as denoted as ~ Section {Number} - {Title of Section} ~ and [Clause {Number}] are there to help locate specific information about this Act of Tepoelan but do not contribute any information themselves and are included as part of this Act of Tepoelan and law of Salanda as denoters to help locate specific information.

~ Section One ~

[Clause One] This act shall give all Salandarian Citizens the right to know that their privacy and data is not shared or collected without their consent however individuals under 18 who give consent will not count as giving consent which means the said breaker shall till be liable and should expect the measures and ramifications for such violations. The Salanda Online Privacy Protection Act (SOPPA) also applies to the safeguarding of Salandarian Citizens wellbeing when they are online. This applies to all companies/businesses/individual/individuals and corporations. If they are found to be in violation of this act they shall be blacklisted and officially blocked in Salanda they shall also be sanctioned by Salanda and fined if necessary and Salandarian Citizens shall be discouraged not to use them or go near them. If the Salandarian Government feels that the

violation has been fixed it can delist them from the official blacklist and unblock as well as unban them.

~ Section Two ~

[Clause One] When a Salandarian Citizen feels that their privacy and data has been shared by said a company or companies/business/businesses/individual/individuals and corporation or corporations, they are encouraged to report it to the Salandarian Government on Salanda's institutions where the appropriate action shall be taken when the matter has been looked into. A Salandarian Citizen can still report it and are encouraged to report it to the Salandarian Government even if the incident has taken place before they have become a Salandarian Citizen.

[Clause Two] The Salandarian Government shall contact the said breaker with the information with the legal measures that are being put on the said breaker with the appropriate legal measures and ramifications as stated above. If the incident is felt by the Salandarian Government as one that can be fixed quickly such on what needs to be fixed shall be stated to the said breaker.

~ Section Three ~

[Clause One] Should any said breaker be a Salandarian Institution other Salandarian Institutions can get involved to implement the legal measures and ramifications.

[Clause Two] If the Salandarian Government wishes to bar a said breaker of the Salanda Online Privacy Protection Act (SOPPA) they can do so and implement the appropriate measures and ramifications provided they provide the Salandarian People, why the said breaker is being barred. The Supreme Court will also get involved for governmental cases on the Salanda Online Privacy Protection Act (SOPPA) to ensure that the said breaker has indeed violated the Salanda Online Privacy Protection Act (SOPPA).

[Clause Three] A said breaker can also be charged with the appropriate measures and ramifications under the Salanda Online Privacy Protection Act (SOPPA) for promoting offensive acts and statements as well as hurtful acts and statements as well as statements that might cause a person mental harm for example, racist and acts of hatred against a said group of people as well as statements pertaining to that group of people with promoting being defined as containing it within the said breakers action for example if the said breaker is a company with an app containing these kinds of things. The said breaker can also be charged for promoting things that a person's body cannot usually take with promoting meaning containing said information that can be harmful and dangerous to a person.

~ Section Four ~

[Clause One] The Salanda Online Protection Privacy Act (SOPPA) shall come into force after being sealed.

~ NEW - Section Five ~

[Clause One] To clear up guidance regarding enforcement of this act, enforcement of this act is strictly limited to the chief moderator and the team he appoints, as well as members of the current government to avoid unelected or non moderating officials from taking action.
