~ Preamble/Definition and Long Title of the Unified Moderation Force Act of 2023 ~

This Act of Tepoelan, the Unified Moderation Force Act of 2023’s long title shall be defined as; Setting up a unified moderation force under the Salanda Internal Police which shall be integrated into the framework which has been set by the Ministry of the Interior Framework Act of 2023 to keep a constant and consistent management of Salanda’s official online institutions and provide the Home Secretary of Salanda reports regarding the management of Salanda’s official online institutions. Any existing moderation organisations in Salanda upon the sealing of this Act of Tepoelan into Law of Salanda shall be merged into the Unified Moderation Force.

~ Section One - Setting up and operation in terms of Roles and Duties of the Unified Moderation Force ~

The Unified Moderation Force (of Salanda) which shall be abbreviated as the UMF or UMFOS shall be set up on Salanda's online institutions by the Salanda Internal Police, this shall include the setting up of a moderation role and include setting up the structure of the Unified Moderation Force such as internal and external security for the Unified Moderation Force and the tasks and roles to be operated within the Unified Moderation Force. The Salanda Internal Police shall also if possible recruit new people and serving officers to the Unified Moderation Force and train them about the roles and duties and responsibilities and how to serve in the Unified Moderation Force, there shall be a head of the Unified Moderation Force, whose title shall be the Chief Moderator and shall be appointed by the Chamber of Provincial Emissary of the Tepoelan there can also be a Deputy Chief Moderator if need be. Each person in the Unified Moderation Force shall take the title and role of Moderator.

The Unified Moderation Force shall monitor and moderate Salanda's online institutions and shall respond to any problems that arise while monitoring and moderating Salanda's online institutions and shall take the appropriate action that the Chief Moderator/Deputy Chief Moderator or they feel when dealing with these problems, if the problems are serious they can regard them to the main branch of the Salanda Internal Police which is under the Salanda Police Force and STADAL (the security organisation of Salanda that was formed by the merger of the Status and Dal governmental organisations giving the portmanteau STADAL). Aside from any problems that arise they will continue with their moderation and monitoring and shall just deal with general day to day things, but they shall split into two groups temporally if a problem arises which shall enable them to continue to deal with their moderation and monitoring while also dealing with the problem/problems. If they need greater help if need be the Salanda Internal Police or the Salanda Police Force with both partially or as a whole shall help them.

The Unified Moderation Force shall provide reports on how its monitoring and moderation are going and any encounters that are made to the Salanda Internal Police who shall further report them to the Salanda Police Force and then the Home Secretary of Salanda who as the head of the Ministry of the Interior of Salanda can then review these reports and make any appropriate action if need be.

The Unified Moderation Force shall be given breaks/vacations rotational cycles, that shall be decided by appropriate action by the Prime Minister of Salanda, breaks/vacations shall also be given on religious or cultural grounds if need be at the notice of Unified Moderation Force staff and officers.

Any other duties and roles shall be given at a one week notice by the Prime Minister of Salanda to the Unified Moderation Force which can be permanent roles and duties or temporary roles and duties for the Unified Moderation Force.

~ Section Three - Budgets ~

The Budget for the Unified Moderation Force shall be placed under the Ministry of the Interior of Salanda's budgets which is given to them annually by the budget that is usually passed by the Chamber of Provincial Emissary of the Tepoelan on the 22nd of June at 23:59 pm.

~ Section Four - Drill Days and Rearmament Days ~

The drill days and rearmament days of the Unified Moderation Force for different cycles of the institution shall be: January 4th or 5th, June 17th-18th, October 2nd or 3rd or 19th and 20th of October and December 16th-17th. On these days different rotating cycles of units of the Unified Moderation Force shall conduct drills for different scenarios and shall receive the necessary support from the Government of Salanda that the Government of Salanda feels is needed.

~ Section Five - Use of SCOM ~

The Unified Moderation Force shall be able to use SCOM (the alert system of Salanda) at the pleasure of the Home Secretary of Salanda, for their roles and duties and for their operation.

~ Section Six - Safeguarding ~

The Unified Moderation Force shall safeguard People in Salanda (meaning in this case everyone who is in Salanda and not just Citizens of Salanda) in its roles and duties in moderating and monitoring Salanda's online institutions on a day to day basis. The Unified Moderation Force shall also safeguard People in Salanda (meaning in this case everyone who is in Salanda and not just

Citizens of Salanda) and the Unified Moderation Force shall protect and respond with the appropriate action with the problems that People in Salanda (meaning in this case everyone who is in Salanda and not just Citizens of Salanda) have.

~ Section Seven - Additional Parts to this Act of Tepoelan ~

These additional parts to this Act of Tepoelan are not riders, as those are prohibited by the Constitution of Salanda (Basic Foundation Laws) but are additional parts to this Act of Tepoelan that are not just related but are need for this Act of Tepoelan and shall as such be listed below:

The Unified Moderation Force may have different ranks of office with their own roles and duties aside from their main roles and duties for those specific ranks of office, which the Chief Moderator or if need be the Deputy Chief Moderator shall be able to decide on with approval by the Chamber of Provincial Emissary of the Tepoelan.

This Act of Tepoelan shall operate within the same category as mentioned above in the preamble with the Ministry of the Interior Framework Act of 2023 and the Salanda Online Privacy Protection Act of 2022 (SOPPA).

~ Section Eight - Entry of this Act of Tepoelan into Law of Salanda ~

This Act of Tepoelan shall become effective as a law of Salanda upon the signing of this Act of Tepoelan after being passed by the Chamber of Provincial Emissary of the Tepoelan and as such this Act of Tepoelan shall become enforceable as a law of Salanda upon the Royal Seal of Salanda being placed upon this Act of Tepoelan.

~ Section Nine - Status of this Act of Tepoelan as part of the Law of Salanda ~

This Act of Tepoelan cannot be repealed or amended by an Executive Order of Salanda and as such can only be repealed or amended by another Act of Tepoelan or by an Amendment to the Constitution of Salanda also known as the Basic Foundation Laws (of Salanda).
